## MCCARTY CAMPAIGN POSTS ONE OF STRONGEST FIRST-QUARTER FUNDRAISING TOTALS FOR A CHALLENGER IN TULSA COUNTY DA HISTORY

*Raises \$159,904.92 in Q1, signaling major momentum with just 7 weeks until Election Day*

Tulsa, OK — Republican candidate for **Tulsa County District Attorney Colleen McCarty** announced today that her campaign raised nearly \$160,000 from 139 individuals in the first quarter of 2026, marking one of the strongest first-quarter fundraising performances by a challenger in Tulsa County District Attorney race history—despite launching the campaign on January 29, 2026, well into the quarter.

With just seven weeks remaining until the primary election, the campaign’s early fundraising strength underscores growing momentum and reflects a broad coalition of support across Tulsa County—from business leaders and law enforcement supporters to grassroots volunteers and community advocates.

“This level of support this early in the race sends a clear message: voters are ready for new leadership,” said campaign manager Rusty Rowe. “Colleen’s campaign is powered by people who want a District Attorney focused on public safety, accountability, and doing the job the right way—not politics as usual. To generate this kind of support after launching late into the quarter puts us on pace to be one of the most competitive DA races Tulsa County has seen in over a decade.”

McCarty, an accomplished attorney and fourth-generation Tulsan, has built her campaign around restoring trust in the justice system, prioritizing victims, and ensuring consistent, fair enforcement of the law.

“Every dollar represents someone who believes we can do better,” McCarty said. “Tulsa County deserves a District Attorney who is transparent, accountable, and serious about public safety. I’m grateful for the support, and we’re just getting started.”

McCarty has earned support from respected leaders across Oklahoma, including former **U.S. Congressman John Sullivan (R) for Oklahoma's First Congressional District**, who stated:

*"Tulsa County needs a District Attorney who will enforce the law, respect taxpayers, and restore integrity to the system. Colleen McCarty has the experience, independence, and leadership to do exactly that."*

**State Representative Kevin McDugle (R)** added:

*"Colleen McCarty is committed to a tough approach grounded in integrity and accountability. She prioritizes evidence-based decision-making over political influence, ensuring that justice is pursued with fairness and transparency. **Calvin Michael Moniz, Republican and District 2 Board Member at Tulsa Public Schools**, also endorsed McCarty:
